justETF positions itself as a platform for investing in exchange-traded funds ("ETFs"). On the justETF.com website, justETF provides information and tools that allow users to learn about investing in ETFs. The core of the offering is a database containing all ETFs, exchange-traded commodities ("ETCs"), and exchange-traded notes ("ETNs") that are domiciled and tradable in Europe.

justETF also offers a web-based tool for independent planning, management, and analysis of ETF portfolios called the "Portfolio Tool." Through our Portfolio Tool, users can create model portfolios, manually map real portfolio holdings, and track the development of their investments.

justETF does not offer custody services, investment advice, or securities trading. The use of justETF serves to support independent investment in ETFs.



## Information on Usage

justETF's portfolio tool can be used through any common web browser. Usage requires registration of a user account with email address and password.

justETF offers a free basic version as well as a paid premium model. Premium access includes advanced analysis functions, the ability to save multiple portfolios and additional filtering options.
